## To receive an update from the proposed mast at Parmoor Working Group:

The application has not as of yet been withdrawn, so ClIr Hussey imagines that it will go back to the Planning Committee at some point. He has written to the National Trust Covenants Officer about the new proposed location which is on National Trust Greenlands Covenant land, but has been deemed by both EE and the Parish Council as the preferred location for both coverage reasons and visual intrusion in the AONB.

The Common is now a designated local wildlife site, and signs would help visitors to realise what a special place it is. The signs will be ladder style, green stained oak with white lettering. #### Members questions: including any items for the next agenda

- 1. **CIIr Webb** – a resident voiced concerns that when the road was resurfaced in Skirmett, the camber is now such that when the water drains it runs straight towards their house. Clerk to report to TfB. **Action:Clerk** 

- 2. She has spoken with the new owner of the field next to the Church in Hambleden – he does not wish to enter into any arrangement for a permanent lease, but is happy to and will open the field for parking when asked to.

- 3. **Clir Armstrong** – the fly tipping is still at Pheasants Hill Common. Clerk to report again. Clir Turner said to forward to him to look into. **Action:Clerk** 

- 4. **Clir Hussey** – BMKERC have contacted asking if the parish council would be amenable to contributing some funds towards a second Chiltern Ranger to carry out more scrub clearing works at Fingest Lane, or if needed the meadow at Ellery Rise. An initial £350 is available to fund one ranger.

- 5. In the play are field Ellery Rise, Frieth, there is some brash left over from hedge trimming last autumn. There is also some put deliberately in front of the bordering hedge to stop children climbing on a privately owned new hedge. These owners would also like to erect a wire fence on the boundary to protect their hedge. Cllr Broad and Clerk will meet with the resident to look at the possibility of the fence. **Action:Cllr Broad/Clerk**
