Public Question Time

A resident of Pheasants Hill had provided before the meeting questions regarding the increase in the precept when there is a substantial amount of money being held in reserve, which were duly answered by the Chair and Councillors including pointing out earmarked reserves. A new page will be added to the website regarding the Film Fund account with a spreadsheet that shows the income and expenditure for that account, and an article placed in the Hambleden Valley magazine re-iterating that parishioners can apply for a grant for activities.

To confirm and approve the minutes of the Ordinary Parish Council meeting held 10th March 2025

Minute 10144

Clerk and any Councillors if appropriate to report on matters arising and any updates from previous minutes which are not on the agenda

- Minute 10125 Clerk signed and returned the Devolution paperwork to Buckinghamshire Highways, who have returned their signed copy.
- Minute 10127 Clerk placed an item about the expansion of Frieth CEC School on the website, the Frieth newsletter and Facebook page as well as asking FVS for information.
- Minute 10128 Clerk ordered the posters and is trying to organise for display cases to be made, the contractor has been away so has not yet replied. These will be displayed throughout the parish on a rotational basis.
- Minute 10129 Clerk forwarded the schedule to FVS.
- Minute 10132 the works to the car parking spaces took place on 17/03/25.
- Minute 10133 Clerk has approached the Open Spaces Society and the Friends of Finings Wood group for help and forwarded the responses to Cllr Hussey.
- Minute 10134 Cllr Armstrong advised the Chilterns Chalk Stream project that the PC were agreeable to match funding the works. The work has been completed, an invoice has not yet been received.
- Clerk continued to promote the elections taking place on 01/05/25 for parish and unitary Councillors. The election notices have been displayed as requested by Buckinghamshire Council.
- Clerk has begun the work for the AGAR and internal audit.
- The trees that were planted on the verge in Fingest will be removed by Buckinghamshire Highways.
- Clerk has confirmed the RoSPA inspection for the play area at Ellery Rise, Frieth.
- The contractor attended to finish the work on the War Memorial in Hambleden.
- AED machines have been checked and reported to The Circle.
- Road closures have been placed on the website and Facebook page.
- Clerk has reported various potholes, damaged signs, blocked drains and faded white lines around the parish. This can be done by anyone via Fix My Street.

12/03/25 – ONE Uniform Planning Update. It was noted that any comments from residents will no longer be visible on the Planning Portal, Buckinghamshire Council say this is to do with GDPR concerns.

19/03/25 - Cllr Hussey attended the West Buckinghamshire Planning Committee to speak on behalf of the

Parish Council in objection to planning application 24/06899/FUL, which was permitted by the Committee.

Minute 10146

To receive any updates from the Climate Change Working Party; to discuss what if any actions the Parish Council can do to respond to the Climate Change emergency

Cllr Hopkins reported that the group met last week and in a positive development, several churches within the parish have agreed to use areas of their churchyards to promote improved biodiversity.

<u>To discuss Pheasants Hill Common and next steps including applying for an adverse possession order</u>

Cllr Hussey had previously circulated a very comprehensive paper regarding next steps. Cllr Jackson proposed seeking legal advice on gaining ownership through adverse possession, Cllr Hopkins seconded. All in agreement. Once it is known if that PC have a valid submission, various local groups such as BBOWT and the Chiltern Society will be approached regarding interest in managing the common. Clerk will forward details to Cllr Hussey about a solicitor and Cllr Webb will enquire with a local firm.

Minute 10148

To discuss the 4 noticeboards in the parish and maintenance needed

Clerk had circulated photographs showing each noticeboard. Most need some minor renovation work; the legs are all fine it is mainly cosmetic. Clerk to obtain quotations for the works, it may be more cost effective to purchase new.

Minute 10150

To consider moving the gate at the field in Ellery Rise higher up the boundary to allow better access

Clerk attended a site visit and had provided photographs of the fences. It was agreed to move the fence, Clerk to obtain quotations.

The landowner has re-iterated in writing that the access owned via the track is permissive and is granted to enable the effective management of the PC's field and is not a right of way. They are happy for this arrangement to continue for access, but it does not constitute an easement and will be reviewed on an annual basis with the outcome confirmed to the PC. They will very kindly make good the boundary where the fence is moved from.

<u>25/05371/FUL</u> & <u>25/07372/LBC</u> – Shoot Lodge Hollow Lane Rotten Row Hambleden – application for construction of two storey front extension, first floor rear extension, replacement glazed infill and window alterations – **no objection**

<u>25/05565/FUL</u> – Units 1 & 2 Rotten Row Farm Main Road Rotten Row Hambleden – Partial/total conversion of units 1 & 2 to create 1 x 2-bed dwelling with associated external alterations – **objection**, we are against change of use, as commercial premises brings benefit to the community
